

Rules and regulations for the PBR Kids' runs
during POLAND BUSINESS RUN 2024 in Krakow

I. Organizer

1. The organizer of the Children's Run that accompanies the Poland Business Run 2024 ("Event") is the Poland Business Run Foundation with the registered office in Krakow, ul. Henryka Siemiradzkiego 17/2, 31-137 Krakow, entered into the register of entrepreneurs kept by the District Court for Krakow-Śródmieście in Krakow, XI Economic Division of the National Court Register under KRS number: 0000617320, NIP: 6762507232, REGON: 364424465 ("Organizer").

II. Objectives

1. Promoting a healthy and active lifestyle among children and adolescents.
2. To promote running as a natural activity
3. To promote spending family time together and actively

III. Date and location

The Kids' Runs will take place on 8 September 2024 in Krakow's Jordan Park on the park green.

The category, distance and start time depend on the age of the child:

- Squirrels (children 4-5 years old; born 2019 and 2020) - distance of 100 metres; start at 10:00 and 12:15
- Lions (children 6-7 years old; born 2017 and 2018) - 200 metres distance; start at 10:45am and 1:00pm
- Foxes (children 8-10 years old; born 2014, 2015 and 2016) - distance 400 metres; start at 11:30am and 1:45pm

Qualification for a category is determined by the year of birth.

The runs take place without timing.

IV. Submissions

An enrolment for participation in the Kids' Run can be made by a parent or legal guardian of the Participant.

Submissions will be accepted from 2 to 31 July 2024 via the form available at polandbusinessrun.pl.

Submission of an application is equivalent to acceptance of the Rules and regulations.

There is a limit of 200 entries for each age category. The order of applications is important.

It will be possible to collect participation packages on the day of the event between 9:00 a.m. and 2:00 p.m. at the registration desk located in Jordan Park in Krakow.

V. Participation

Children between the ages of 4 and 10 (year of birth counts) are eligible to take part in the PBR Kids.

In order to be allowed to start in the PBR Kids, a parent or legal guardian must be present during the verification of the Participant at the registration desk.

Children will compete in series. A maximum of 20 children are allowed to start in one series. Assignment to the series is based on the order in which the starting packages are issued.

Participants take part in the race on their own (without a parent/guardian).

At the Registration Desk, participants receive their start packs, including a T-shirt and a start number.

During the run all participants must have their start numbers placed horizontally to the front of their T-shirt (or sweatshirt or jacket).

The organiser provides medical services during the run.

VI. Fees

The entry fee for taking part in the run is PLN 35 and will be donated in full to help a young beneficiary of PBR Kids.

As part of the participation fee, participants can use all the attractions for children available in Jordan Park

VII. Nagrody

All participants who complete the Kids' Run will receive commemorative medals at the finish line.

The Organiser may provide additional prizes.

VIII. Final provisions

1. During the race, Participants should follow the instructions given by the security personnel, order service and other persons appointed by the Organiser.
2. The parent/legal guardian declares that the participant is fit to take part in the run, that they are not aware of any health reasons excluding the participant from taking part in the run and that they take part at their own risk, acknowledges that taking part in the run

involves physical exertion and entails a natural risk of accident, bodily injury and physical harm (including death), as well as damage and loss of a material nature. In addition, there may be other risks associated with participation in the competition that cannot be foreseen at this time. Signing the declaration of knowledge of the Rules and Regulations means that the parent/legal guardian of the participant has considered and assessed the extent and nature of the risks involved in taking part in the run, and is taking part voluntarily and solely at their own risk. Decisions of doctors regarding continuation of running during the event are final and irrevocable.

3. At all times during the Competition, the child shall be in the care of a parent/legal guardian. They shall take full responsibility for the care of the child during this time and shall be liable for any damage caused by the child.

4. Any matters not covered by the Rules and Regulations shall be decided by the Organiser. If any provision of these Rules and Regulations is found to be partially or wholly invalid or unenforceable, all other provisions (in whole or in part) shall remain valid.

IX. Information on processing of personal data

1. The administrator of your/your child's personal data is the Poland Business Run Foundation. The Administrator can be contacted in writing by post at the address of the Administrator's registered office: ul. Siemiradzkiego 17/2, 31-137 Kraków and by email: biuro@polandbusinessrun.pl.

2. The Administrator has appointed a Data Protection Officer, who can be contacted traditionally by writing to the Administrator's registered office address or by email at: iod@iods.pl.

3. Your/your child's data will be processed in order to organise, execute and announce the results of the children's run as part of the Poland Business Run event on the basis of your voluntary consent and in connection with these Rules and Regulations of the Kids' Run, in accordance with Article 6(1)(a) of The Personal Data Protection Regulation (RODO). Additionally, if you give your consent, your child's image will be processed in order to promote and fulfil the needs of the Administrator, in accordance with Article 6(1)(a) of the Personal Data Protection Regulation (RODO).

4. The provision of personal data by you is entirely voluntary and failure to do so may result in the impossibility to fulfil the purposes indicated above.

5. The recipients of your personal data will be entities authorised by law. Your data may be provided to entities processing personal data on behalf of the Administrator, e.g. IT service providers, entities providing legal and advisory services and other data processing entities, for the purposes specified by the Administrator - however, such entities process data only on the basis of a contract with the Administrator.

6. Your/your child's personal data will be processed until the purpose of the processing has been fulfilled or until you withdraw the consent you have previously given.

7. In relation to the processing of personal data, you have the right to: access to the content of your personal data, receive a copy of your personal data, correct your personal data, erase your personal data, restrict the processing of your personal data, object to the processing of your personal data, withdraw your consent to the processing of your personal data at any time without affecting the lawfulness of the processing carried out before its withdrawal - if the processing is based on the consent granted to us - in the cases and under

the conditions set out in the Personal Data Protection Regulation (RODO). The rights mentioned above can be exercised by contacting the Administrator.

8. You have the right to file a complaint with the President of the Office for the Protection of Personal Data when it is justified that your/your child's personal data is being processed by the Administrator contrary to the provisions of the Personal Data Protection Regulation (RODO).

9. Your/your child's personal data shall not be processed by automated means, including profiling.

10. Your/your child's personal data will not be transferred to international organisations or third countries.
